

OHRP Updates Single IRB Requirements in Response to COVID-19

Due to the COVID-19 public health emergency, the Office for Human Research Protections (OHRP) has determined that, for studies that are conducted or supported by HHS and subject to the 2018 Requirements, and for purposes of 45 CFR 46.114(b) (2)(ii), an exception to the requirement to use a single IRB is appropriate for certain eligible cooperative research.

Upcoming Reaccreditation Site Visit for the Institutional Animal Care and Use Program

AAALAC previously planned to conduct the University's animal care and use program reaccreditation site visit in the spring/summer of 2020. As of now, AAALAC is planning to visit on March 15th & 16th, 2021. While we are working with AAALAC to conduct as much of the visit as remotely as possible, site visitors will need to visually inspect each area on campus where vertebrate animals are used. The IACUC Coordinator will be in contact to coordinate a schedule and discuss the COVID safety precautions we will be taking during the visit.

Changes to Animal User Occupational Health and Safety Enrollment

We are still unable to accept electronic copies of the form at this time, so a hard copy must be sent to Sansum Occupational Medicine. All OHS evaluation forms must now be sent directly to the OHS Physician at Sansum Clinic. **Mailing instructions** are included in the form. The IACUC will still be notified of any recommendations and the outcome of evaluation.

Resumption of Basic Training for New Animal Users

Basic training for new animal users has resumed. Researcher Training Checklists must now be submitted electronically to the IACUC Coordinator, and a discussion of the training with the IACUC Coordinator will take place via Zoom. New animal users must obtain permission from their building committee prior to entering any buildings on campus.

International Shipping and Export Control

International shipments must comply with export control laws. Shipments of some items to certain countries may require a license from the U.S. government.

The campus Export Control Officer can help you determine when you need a license to ship or hand carry items (e.g., equipment, samples, fabricated parts, etc.) to international destinations. The applicability of the regulations to the items you are shipping or hand carrying depend on what the item is, where the item is going, and who will be receiving the item.
